MINUTES OF EMERGENCY SERVICES DISTRICT 2
SPECIAL MEETING AUGUST 21, 2025

Call to order – At 5:01pm, President Riley called the meeting to order.

Commissioners present: Commissioner Hayman, Commissioner Schwebach, Commissioner Marshall, Commissioner Murphey and President Riley were present.

Pledge of Allegiance, Texas Pledge and Opening Prayer:

The pledge of allegiance and Texas pledge were recited, and opening prayer was given by Commissioner Hayman and guests were welcomed.

Minutes Prior Meeting – Commissioner Hayman made a motion to approve the August 5, 2025, minutes. Motion seconded by Commissioner Murphey and passed unanimously.

Review, discuss & take action regarding the treasurer's report and pay bills

A motion was made by Commissioner Murphey, seconded by Commissioner Marshall to table payment of Ken Campbell until meeting on September 2, 2025. Motion carried.

Review, discuss & take action regarding the adoption of the District's proposed 2025-26 Budget

A motion was made by Commissioner Schwebach, seconded by Commissioner Murphey to accept the 2025 Budget as written for 2026, upon amending it for the meeting on September 2, 2025.

Review, discuss & take action regarding the adoption District's 2025 ad valorem tax rate at the rate of \$0.10 per \$100 valuation and authorize the appropriate district officer and officials to take all necessary action to implement same

A motion was made by commissioner Hayman, seconded by President Riley, "I move that the property tax rate be increased by the adoption of a tax rate of \$0.10000, which is effectively a 0.00 percent increase in the tax rate."

A motion was made by Commissioner Hayman, seconded by Commissioner Murphey to send Resolution letter to Ken Campbell, and then to Betty Davis.

Review, discuss & take action regarding ESD Insurance

President Riley made a motion, seconded by Commissioner Marshall to accept quote to Texas Mutual for VFIS Worker's Comp and to pay at the meeting on September 2, 2025 upon getting an invoice. Motion carried.

Review, discuss & take action regarding contract between SJC ESD 2 and Waterwood Improvement Association, Inc.

A motion was made by President Riley, seconded by Commissioner Murphey to approve the agreement contingent upon complying to any legal requirements in Texas. President Riley and Commissioner Murphey voted for. Commissioner Schwebach and Commissioner Mashall voted against. Commissioner Hayman abstained.

Review, discuss & take action regarding SJC ESD 2 logo

A motion was made to table this until the meeting on September 2, 2025 after making some changes to the design.

Commissioner Hayman made a motion to adjourn the meeting. Motion seconded by Commissioner Murphey. Meeting adjourned at 6:07 pm.
